- (f) To submit the views of members to the Government and public bodies on legislation or other members of professional interest to or affecting members.
- (g) To provide opportunities for its members to meet to exchange views and to discuss matters of interest, particularly between practicing and nonpracticing members.

#### NOTICE OF MEETING

NOTICE is hereby given that the 45th Annual General Meeting of The INSTITUTE OF CHARTERED ACCOUNTANTS OF GUYANA will be held on Thursday 31 March 2011 at 17:00 hours at the GCIS Building, Main Street, Georgetown, in order to:

- 1. Receive and consider the Report of the Council for the year ended 31 December 2010.
- 2. Receive and consider the audited Financial Statements for the year ended 31 December 2010.
- 3. Consider the increase in annual membership dues to \$20,000.
- 4. Elect members of the Council for the ensuing year in accordance with section 4:7 of the Institute's Bye- Laws.
- 5. Appoint an Auditor for the ensuing year.
- 6. Transact such other business as may be properly transacted at an Annual General Meeting.

#### It should be noted that:

- a) Nomination for election to the Council shall be in writing, signed by the proposer and seconder, such nomination shall be delivered to the Secretary at least three (3) days before the time of the meeting at which the election is to take place. Election shall be by show of hands or by ballot of those present which ever may appear to the Chairman of the meeting to be more convenient.
- b) In the event of an equality of votes between two or more candidates, there shall be a further election to decide between them. The declaration of the Chairman as to the results of the election shall be final.
- c) Only those members who have paid up their current subscription are eligible to vote at the meeting.
- d) The Council shall consist of eight members and of the members of the Council, at least three (3) shall be members in practice or in service of the members in practice, and at least three (3) shall be members not in practice or in the service of members in practice.

#### TECHNICAL ACTIVITIES

# REGULATORY / MONITORING ACTIVITIES

At the end of 2010 the first cycle of firm visits under the ICAG/ACCA practice monitoring program concluded. Every practice member has therefore been visited once. The feedback received so far from members has been positive. The second cycle of visits is due to commence in January 2011.

During the year the ICAG participated in a Private Sector initiative to design a corporate governance code for Guyana. The draft code is presently under review.

The ICAG also contributed towards the refinement to financial reporting regulations being designed by the Bank of Guyana for application by licensed financial institutions in Guyana.

#### COMPLIANCE WITH INTERNATIONAL ACCOUNTING AND AUDITING STANDARDS

During the year continuing professional sessions were held on relevant developments in international accounting and auditing standards. Additionally the ICAG improved the process of notification to members of changes in these frameworks. Apart from immediate notification of relevant releases from IFAC and the IASB, the ICAG also reactivated its quarterly newsletter in which the main features of recent pronouncements are highlighted.

In February 2010 the ICAG's Action Plan was approved by IFAC and published on its website. Efforts continued during the year to achieve goals set out in the plan.

#### CONTINUING PROFESSIONAL DEVELOPMENT

In addition to regular notifications of relevant developments in accounting and auditing, the ICAG held four seminars.

- 1) Myer Briggs Type Indicator Instrument (MBTI) Seminar was conducted by Ms. Elizabeth Cox, EMBA, MHP, FLMI, Strategic Advisor/Trainer on June 11, 2010. The MBTI Instrument gave an assessment of a person's preferences, seeking to understand oneself and recognizing strengths and possible pitfalls and blind spots.
- 2) <u>Developments in Accounting for Financial Instruments Seminar</u> was conducted by Harryram Parmasar, Partner of Parmesar and Khalil Alli, Partner of Jack. A. Alli, Sons and Company. The seminar examined the following areas:
  - IFRS 9:Classification and Measurement of Financial Assets
  - Classification and Measurement of Financial Liabilities
  - Impairment methodology
  - Fair Value Measurement Guidance
- 3) <u>Audit and Quality Control Standards Seminar</u> was conducted by Mr. Rameshwar Lal, Senior Partner, TSD Lal & Co and Mr. Leslie Veerasammy, Partner, Nizam Ali & Co. The seminar examined developments in audit and quality control as well as matters identified by the ACCA Practice Review Team as areas of common weakness.
- 4) <u>National Accounts of Guyana Seminar</u> which was conducted by Ms. Sharon Kreuter, Head National Accounts Department, Bureau of Statistics and her team. The seminar/workshop examined the following key areas:
  - What are National Accounts and GDP
  - Overview of Guyana's GDP
  - Other information compiled by and available at Bureau of Statistics
  - Sources of data for National Accounts
  - Estimation techniques
  - Impact of recent rebasing of National Accounts

#### MEMBERSHIP / PUBLIC RELATIONS

A main goal of the Council continued to be the expansion of membership. During the year the Institute lost several members primarily due to migration however the total membership number increased from sixty-two at the previous year end to sixty-five. The Membership Committee continues to encourage eligible persons to join the ICAG to enjoy the lower fees for CPD sessions, as well as to network with other professionals in Guyana.

In November 2010 the ICAG hosted its Annual Reception and Dinner at which members and their guests were treated to an evening of entertainment that included Dave Martins of Tradewinds fame.

The ICAG's website is active and includes a brief history of the Institute, its objectives, the Council composition, members and various ICAG publications.

#### STUDENTS AFFAIRS

#### **ACCA**

During the year fourteen (14) students successfully completed the ACCA final examinations.

Over the period 2006-2010, one hundred (100) students completed the ACCA final examinations.

## **Premises**

The ICAG entered a lease agreement from 01 March 2010 for new office space located at the GCIS Building on Main Street, Georgetown.

With regard to the property at Lance Gibbs Street, efforts to reactivate the Guyana Professional Society, of which the ICAG is a member and which is the legal owner of the property, continued during the year but with no substantial results. The Guyana Professional Society also owns a property in the Durban area close to the Cliff Anderson Sports Hall. The ICAG informed the Guyana Professional Society of its desire to acquire the Lance Gibbs property but no decision has been taken to date.

During the year the Council started to examine alternative properties for acquisition.

## **FINANCE**

The Institute's financial position continues to be sound. The General Account recorded a surplus of \$353 thousand, less than the prior year when the ICAG benefitted from the successful hosting of the ICAC Annual Conference. The Education Trust Fund recorded a surplus of \$2.6 million supported largely by the subvention from ACCA received under the Joint Exam Scheme arrangement. The Institute's cash position stood at \$47.4 million.

Due to increasing annual fees required by IFAC, the Council agreed to table a resolution at the annual general meeting to increase annual membership dues from \$15,000 to \$20,000.

#### INVESTIGATIONS, DISCIPLINARY AND APPEALS

The Investigation Committee submitted its report on one matter involving alleged non-compliance with IFRS. Based on the report submitted, the Council concluded the matter. There are no pending matters to be addressed by the Investigation or Disciplinary Committees.

#### **AFFILIATIONS**

The Institute maintained its membership with IFAC and ICAC during the year.

#### **IFAC**

In February 2010 IFAC approved and published on its website the Action Plan for Guyana as prepared by ICAG. The Plan identifies the main actions planned towards compliance with the Statements of Membership Obligations as defined by IFAC.

The main objectives incorporated in the Action Plan are:

- 1) Improve quality of audit and assurance environment through an effective quality assurance program.
- 2) Improve educational standards of members.
- 3) To establish and maintain processes for effective implementation of IAASB pronouncements.
- 4) Raise awareness of the provisions of the IFAC Code of Ethics.
- 5) Encourage adoption of IPSASs.
- 6) Enhance the ICAG's investigation and disciplinary procedures
- 7) Continue to support the application of IFRS.

The ICAG's Action Plan sets out the planned actions to meet these objectives. At Council's monthly meetings, the status of planned actions is reviewed. On an annual basis a report is required by IFAC on the achievement of the planned actions.

## *ICAC*

During the year the Institute was represented on the ICAC by Harryram Parmesar (serving as President) and Khalil Alli (serving as Alternate Director for ICAG and Representative for the Institute of Chartered Accountants in England and Wales).

Key initiatives undertaken at ICAC during the year are outlined below.

#### Enhancing Quality Assurance Reviews & Audit Standards within the Profession

During the year, efforts to enhance quality assurance review systems within the region continued with the implementation of the ICAC/ACCA practice monitoring programme. The practice monitoring programme has been underway in Barbados, Guyana, Trinidad and Tobago and commenced in the Eastern Caribbean during the year. The process has been progressing very well in these territories as the ICAC continues to receive positive feedback from practitioners who have been seeing the benefits of the monitoring reviews in helping to improve their audit procedures and the quality of audits.

## Enhancing Our Role & Contribution Internationally

During the year, the ICAC liaised with member institutes with regard to the timely submission of their Action Plans in compliance with IFAC's Statements of Member Obligations (SMOs). The Institute of Chartered Accountants of Guyana's Action Plan was the first to have been completed and approved by IFAC in February 2010. Action Plans for Barbados, Bahamas, Jamaica and Trinidad and Tobago were subsequently completed and submitted to IFAC.

During the year, the ICAC was pleased to submit an endorsement to the IFRS Foundation in support of the Institute of Chartered Accountant of Barbados' nomination of its President, Andrew Brathwaite, to serve on the membership of International Accounting Standard Board (IASB) SME Implementation Group (SMEIG). The nomination was subsequently confirmed.

## Strengthening the Accountancy Profession through Regional Initiatives

The ICAC continues to make a meaningful contribution regionally through its representation on the Board of Trustees of the Caribbean Court of Justice Trust Fund, which comprises appointees from nine institutions representing civil society in the region and on the Board of the Caribbean Association of Industry and Commerce (CAIC), an organisation that represents the interests of the private sector in the Caribbean. The ICAC is represented on the Board of Trustees of the CCJ Trust Fund by Harryram Parmesar and on the Board of CAIC by Anthony Pierre, ICAC Director.

## Broadening ICAC's Membership

Efforts to expand the ICAC's reach to other potential bodies in the region and to increase its membership bore fruit as the Suriname Association of Accountants was admitted to membership in June 2010. The Certified Management Accountants of Canada (CMA-Canada) was also admitted as ICAC's fifth affiliate member body in June 2010.

## Annual ICAC Conference - Enhancing Regional Networking & Professional Development

The 2010 ICAC Annual Conference was hosted in the Bahamas while the 2011 Conference is scheduled to be held in Kingston, Jamaica.

#### **APPRECIATION**

The Council wishes to record its appreciation to all members who served and volunteered their services to the various tasks executed during the year. We also wish to record our appreciation to the administrative staff of the Institute.

We look forward to even greater support in the coming year as we aim to collectively strive to meet the everexpanding needs of the profession.
